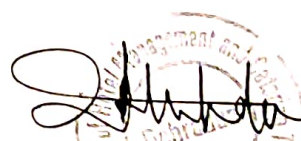

A duty officer is assigned weekly to oversee activities and ensure no incidents occur.

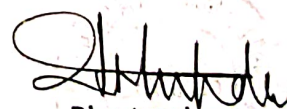
The following areas will be regularly monitored:

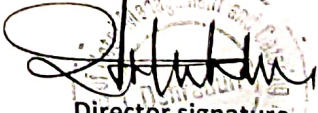
Committee Responsibilities:

SC/ST & OBC Cell

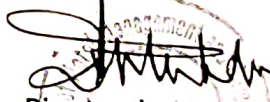
